Minutes of the May 15, 2023 Montclair Public Library Board of Trustees Meeting

The 2178th meeting of the Montclair Public Library Board of Trustees was held on Monday, May 15, 2023 at 7:00 p.m. in accordance with New Jersey Law.

The meeting was called to order by President JoAnn McCullough at 7:07 pm.

Open Meetings Act:

President JoAnn McCullough announced that the meeting was in compliance with the Open Meetings Act. Notice of this meeting was posted on the Library website, in the Library, at the Municipal Building and advertised in the Star Ledger. Notice of the change of venue to an Hybrid meeting was posted on the library website.

<u>Election of Treasurer to the Board</u> - Diana Lunin moved to elect Brian Clarkson for Treasurer of the Board for 2023 and JoAnn McCullough seconded. The motion was carried unanimously.

Report from The MPL Foundation - Mary Packer

The Lit Gala

The Gala was a great success with over 200 guests raising nearly \$200,000 in gross receipts. Both the raffle and the Fund-A-Need dramatically outpaced expectations. Final receipts are still coming in, but the net amount raised by the Gala exceeds \$140,000. The Fund-A-Need proceeds of \$38,800 have already been distributed to the library to address the immediate needs described in each category: Community Reads, Teen Room updates, the Children's Room at the Bellevue Avenue Branch, Children & Youth programming, Adult School support, Special Collections, and the Director's Circle. The remainder of the funds will go through the regular request and disbursement process and will support those special projects, programs, and services that enhance our wonderful library beyond the essential municipal funding for personnel, hours, operating costs, and building upkeep.

It remains to be seen whether and to what extent the Gala may impact giving to the Annual Appeal. On the one hand, the Gala attracted new supporters and re-engaged a number of

former supporters and we hope to continue to cultivate those relationships. On the other hand, those who gave so generously in April may be unable to support the library to the same degree at year's end. We will consider these possible outcomes as we move into end-of-year planning in the fall.

Board Development

Having evaluated the skill sets and knowledge that we need on the Foundation Board going forward, the Board has generated a robust slate of prospective Board members and has begun the process of gauging interest and setting up interviews. We hope that this Board recruitment process will result in 2-4 candidates joining the Foundation Board in September.

Grants

Of the seven grant proposals submitted so far this year, in partnership with the library, we have received one award, several declinations, and two remain outstanding. As we complete the follow-up related to the Gala, the Foundation will turn its attention back to pursuing additional grants.

Library Report:

Assistant Director Selwa Shamy reported that:

Building & Safety

- ADA Bathroom Project all bids from the first round were rejected due to being out
 of budget range. A second round of bids is in progress and a second walk through
 was done on May 10. The county is waiting to see what bids come in before
 deciding whether they will increase the funds and extend the deadline. The bid
 deadline is May 24.
- A solar umbrella with a mobile charging station was installed at one of the tables outside of the main library. Within a week, the two iPhone charging cables were torn from the unit. Replacement cables will be installed -- if they are removed again they will not be replaced. There are USB outlets where people can use their own cables.
- A table read for an active shooter scenario was led by officer Rober Romito at the library on May 3. Members of the police, fire, and EMS departments sat down with Tim Flowers, Janet Torsney, Tom Hoesly, Adrienne Burke, and Selwa Shamy. The training process for this kind of threat is underway with staff.

Schools

 Tim Flowers, Tracy Crawford, Ruby Williamson and Selwa Shamy met with members of the school system restorative justice team on May 9. The RJ team was very helpful and generous with their time.

Services

- Seed Library out of 200 packets of seeds that were created, 126 have been taken so far. Flowers and herbs are the most popular.
- Library of Things The Video to Digital converter is very popular, as are the musical instruments. There were six checkouts in the first week and many compliments and much interest at the STEM Fair at Edgemont School where the collection debuted.

Community

- Montclair Literary Festival sessions were held on the main library lawn and in the auditorium on May 6. Attendance at library hosted sessions was over 500.
- Montclair Gateway to Aging has been partnering with the library to offer SmartSeniors/SmartTECH classes taught by seniors for seniors. The next set of sessions will be May 17, May 24, May 31 and June 7.

- More than 400 people came through the first Flea for All; 35 of them got new library cards. Also raised \$400 for the library.
- More than 200 people attended the screening of the Judy Blume documentary.
- Leading French author, Anne Berest, closed out Montclair Literary Festival at the library on May 11.
- Gearing up for major Big Read next spring with our partners Montclair High and MFEE. Book: The Best We Could Do, a graphic novel by Thi Bui. Period: February-May, 2024.

- The Building Committee is reviewing RfQs for HVAC and water-remediation at BAB.
 Vendor should be hired soon
- Continue to talk to Bryan Murdock about how MSU could help develop the cafe space
- Josh Weston has graciously offered to replace the benches in the Plaza at the main library.
