Building & Security

Operations

- Redundant phone lines are costing the library a great deal of monthly losses. Two
 of the Verizon bills doubling is what flagged the issue.

- Procurement card: cards arrived and awaiting policy implementation
- Capital: \$5 million bond ordinance passed 1st reading unanimously on 3/25. Due to a procedural, the 2nd reading could not take place on the 8th.
